1. I, Anna Maree Scott, (New Zealand Passport No: No. LN993769), am the Defendant in the above legal action brought by the Malayan Racing Association. I wish to tender the following statements to Your Lordship and to the Malayan Racing Association, the Penang Turf Club, the Perak Turf Club, the Selangor Turf Club and the Singapore Turf Club.
2. Between 3.1.2019 to 17.2.2019, I had by way of my writings and postings published in my Facebook Account under the name of "Anna Scott" at <https://www.facebook.com/AnnaScott.2931> and in my Facebook Page under

the name of "Anna Scott Holdings Racing KL" at <https://www.facebook.com/Anna-Scott-Holdings-Racing-KL202589333127363/>

numerous allegations and accusations against the Malayan Racing Association ("MRA") and its four constituents Turf Clubs namely:-

- (1) The Penang Turf Club ("PNTC")
- (2) The Perak Turf Club ("PRTC")
- (3) The Selangor Turf Club ("SLTC")
- (4) The Singapore Turf Club ("SNTC")

3. I acknowledge that my above mentioned writings, postings and publications encouraged or invited third party publications of defamatory allegations and accusations in the comment section of my Facebook Account and Facebook Page.

4. I also admit that I had participated in the defamatory comments by way of my writings, postings and publications in my Facebook Account and Facebook Page.

5. I now acknowledge that all of my allegations and accusations against the MRA, PNTC, PRTC, SLTC, SNTC, their Office Bearers, Stewards and Officials were baseless, unsubstantiated and without any truth.

6. I truly and sincerely regret my actions which has caused MRA, PNTC, PRTC, SLTC, SNTC, their Office Bearers, Stewards and Officials severe embarrassment and substantial distress. I am totally remorseful.

7. I take this opportunity to unreservedly and unconditionally apologies to MRA, their Office Bearers, Stewards and Officials for the libel I had written, posted and published against them in my Facebook Account and Facebook Page.

8. I without any hesitation whatsoever now wish to immediately and unconditionally withdraw all and every libellous allegations and accusations of mine against MRA, PNTC, PRTC, SLTC, SNTC, their Office Bearers, Stewards

I hereby undertake never to write, post and/or publish those accusations and allegations or any other like or similar accusations and allegations against the MRA, PNTC, PRTC, SLTC, SNTC, their Office Bearers, Stewards and Officials in my Facebook Account or Facebook Page or in any other social media or platform.
10. To the Racing Stewards, the Acting Chief Stipendiary Steward and the other officials of the Penang Turf Club:-  
I admit to having done the following:
- (i) surreptitiously audio recorded the Inquiry Proceedings conducted by the Stipendiary Stewards and the Appeal Proceedings conducted by the Racing Stewards in connection with the "ILUMINADO" inquiry and appeal;
  - (ii) retained a copy of the above mentioned audio recordings despite being ordered by the Racing Stewards to delete those audio recordings; and
  - (iii) posted the audio recordings on my Facebook Accounts.
11. I truly regret my poor judgment in this regard.
12. I apologise unreservedly for having:
- (i) surreptitiously audio recorded the Inquiry Proceedings conducted by the Stipendiary Stewards and the Appeal Proceedings conducted by the Racing Stewards in connection with the "ILUMINADO" inquiry and appeal;
  - (ii) disobeyed the Racing Stewards' direction to me to delete those audio recordings; and
  - (iii) posted the audio recordings on my Facebook Accounts.
13. I further admit to having accused the officials of the PNTC of :-
- (i) forging my signature on the Malayan Racing Association Notification Of Fine (NOF) Form; and

- (ii) failing to inform me of the fine imposed by the Stipendiary Stewards at the conclusion of an Inquiry on 6.10.2016 in respect of "ALL WEALTH" returning positive to a prohibited substance.
14. I now realise and admit that I was wrong and that I made a mistake.
15. Accordingly, I wish to unconditionally withdraw all of the above mentioned allegations and I tender my sincere apologies to the officials of PNTC.
16. I humbly request that my apology, retraction and undertaking be recorded by this Honourable Court.
